Eligibility requirements for SNAP are more generous for senior citizens and disabled persons than for others. Individuals 65 and older who are living alone with a net monthly income of \$1,915 can receive benefits. A two-person household with an elderly or disabled person and an annual income of \$31,020 also qualifies for benefits.
