Massachusetts Medical Necessity Criteria

Azar that over-reliance on MCG and InterQual created the basis for granting appeal rights to a class of patients hospitalized under observation. Certain patients hospitalized under observation may have had their due process rights violated by applying MCG and InterQual in admission status decisions.

Acute inpatient psychiatric hospitalization is defined as the highest intensity of medical and nursing services provided within a structured environment providing 24-hour skilled nursing and medical care. Full and immediate access to ancillary medical care must be available for those programs not housed within general medical centers. All of the following are required to meet the medical necessity criteria:
